

New Year's Eve CONTEST RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. THE CONTEST IS VOID WHERE PROHIBITED BY LAW.

1. How to Enter the Contest:

- (a) The NEW YEAR'S EVE contest will begin on November 14, 2011 and end on December 1, 2011 at 8:00 am.
- (b) To participate in the contest, log on to cw69tv.com before 12:00am on December 1, 2011, and click on the contest link to enter our online contest.
- (c) Incomplete entries will be disqualified. One entry per household, additional entries per household will cause all entries from the household to be disqualified. Address provided must be home address; all other addresses and PO Boxes will be disqualified.
- (d) Sponsor is not responsible for technical or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, or failed, incomplete, garbled or deleted computer or network transmissions, inability to access any Web site or on-line service, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. If the judges determine, in their sole discretion, that there is any suspected or actual electronic tampering with the Contest or if technical difficulties compromise the integrity of the Contest, the judges reserve the right to void the entries at issue and/or terminate the Contest and conduct a random drawing to award the prize among all eligible entries received as of the termination date. If the Contest is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at www.cw69tv.com. If, for any reason, the Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest. Sponsor reserves the right to disqualify at its sole discretion any entrant it suspects of tampering with the operation of the Contest or website or violating the Official Rules of the Contest.

- (e) Broadcasts are subject to preemptions and scheduling changes. If such changes occur they will be posted on the WUPA-TV website.
- (f) Entry deemed made by holder of e-mail account.
- (g) Odds of winning depend on number of eligible entries.

2. Eligibility Restrictions:

- (a) The contest is open to Georgia, USA residents who are 18 years of age or older. Employees of WUPA-TV, CBS Corporation, other television and radio stations in the Atlanta market, and their affiliates, subsidiaries and advertising agencies and their immediate family members and persons living in the same household are ineligible to participate or win.
- (b) Viewers are eligible to win a WUPA-TV contest only once every sixty days. Only one winner per household is permitted in any contest. Viewers are eligible to win a prize valued at \$600.00 or more only once every six months.
- (c) All entries become the sole property of Station and will not be returned. By entering, entrants agree to abide by these rules, and warrant and represent that their entry is their original work.
- (d) Contestants are required to provide truthful information and the Station will reject and delete any entry that it suspects to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13.

- (a) A pass for two people to see a screening of the movie NEW YEAR'S EVE at a central Atlanta theatre on December 6, 2011. **Retail Value: \$21**

- (b) Entries will be received via an online registration and winners will be chosen in a random drawing on or about December 1, 2011 from all eligible entries received by 8:00am on December 1, 2011. Winners will be notified by telephone on or about December 1, 2011.

- (a) Payment of all federal, state and local taxes are the sole responsibility of the winner and winners may receive an IRS Form 1099 or equivalent from Station.
- (b) By participating in the contest, the winners agree to have their name, voice, or likeness

used in any advertising or broadcasting material relating to this contest, and to sign a publicity release, affidavit of eligibility and release of liability prior to acceptance of the prize. By accepting the prize, each winner grants to Station the right to use the winner's name, voice, picture and/or likeness for purposes of advertising and publicity in any and all media now known or hereafter invented, without further permission or additional compensation (except where prohibited by law).
